Lobbyist Report/Update -

Danny Furman and Erin Snow Introduction Over view of their projects and what may affect Coroners

Eagle, Routt, Summit = I-A Grand II-A Pitkin II-B Fremont II-C Archuleta, Delta, Montezuma, Ouray III-A Las Animas III-C Saguache V-A

Glassmire – there was a Bill that went through requiring counties to have 5 commissioners. Boulder County still only has 3

Senate Bill 20 – Timely death certificates: Bi-partisan bill. Changes general time frame within which a death certificate must be filed with the Registrar.

- The bill changes the time frame required to file a certificate of death with the state registrar from 5 days after a death occurs to within 72 hours of assuming custody of a dead body.
- The following exceptions apply and require the certificate of death to be completed and signed as soon as practicable:

- The individual responsible for completing the medical certification for the death certificate is unable to complete the medical certification for the death certificate within the required timeframe.
- Additional inquiry into the cause and manner of death is required by current law, or
- A coroner, medical examiner, forensic pathologist, or other qualified individual determines that additional time is required to determine the cause and manner of death.

SB-111

- The bill gives labor protections to Colorado public employees, including county employees:
 - Gives the right to discuss workplace issues, organize or join an employee organization, and participate in the political process outside of work hours
 - Provides protection from retaliation for workers who raise concerns
- It charges CDLE with enforcing any alleged violation of these rights
